1.1. Overview

Population

- Ethnic distribution: 5.4 % of the population are Egyptians
- Main source of livelihood: support by other persons plays a major role as compared to the Kosovar average

Performance of the local business sector

- Number of businesses per 1,000 economically active inhabitants (91) is among the highest in Kosovo (average: 76)
- The development of businesses and employees is positive, but slightly below the Kosovar average
- The business entry rate (11.0 %) is somewhat lower than for Kosovo in total (13.6 %)
- The business exit rate (3.9 %) is also below the Kosovar value (6.5 %)
- Sectoral structure of the local economy: the most important sectors are trade, personal services, manufacturing, business services as well as hotels and restaurants
- Size of businesses: the highest share of employees (31.2 %) are working in businesses with 2 to 4 employees
- Legal form of businesses: 89.3 % are individual businesses (Kosovo: 85.2 %)







Figure 1 Population by age groups, in %






Figure 2 Population by ethnic background, in %







The number of enterprises and employees are based on data from the Tax Administration of Kosovo (ATK). The database of ATK only includes enterprises that are paying taxes.





Figure 4 Development of the number of businesses and employees, 2010-2013




















Figure 7 Development of the number of students in secondary schools, 2011-2014











Index (2009=100)













Figure 10 Development of the number of tax consultancies, 2009-2014




